We would like to inform you that as of 16 May 2016, the General Terms and Conditions of Co-operation with Clients (the "Rules") that constitute the basis for the provision of our services and cooperation with you will change. You will soon receive the new Rules together with information indicating the main areas that have changed.

The Rules have been updated to bring them in line with the existing macroeconomic and legal environment. The amendments concern primarily the complaint handling, cybersecurity and interest on accounts and deposits in the event of negative interest rates in the interbank market.
