Orders sent after the above mentioned times will be executed on 2nd January 2012.

2. Deposits:

made by phone – up to 1.00 pm
 sent electronically or submitted in a paper form up to 12.00 am.
 sent via keyed fax – up to 12.00 am

3. Foreign inflows:

- received by our Bank up to 1.00 pm will be executed on the same day.

4. All inflows from the National Clearing House into Customers' accounts will be credited according to NCH's schedule of work for that day.

5. Resetting the balances for budgetary units – budgetary units which at the end of the year should have a reset account balance are kindly asked to immediately submit written instructions to reset the account balance.

6. Trade Services Products, i.e. Export and Import Letter of Credits, Collection and Guarantees: 23rd December 2011 up to 10.00 am

Transaction confirmations will be sent in the form of a PDF file, on the day of transfer execution, to the e-mail address to which bank statements are presently
